TERMS AND CONDITIONS:-



2. **Verification of all the certificates of candidates may be ensured from the competent issuing authority at the time of joining.**
3. **The candidates whose registration with H.P. Para-Veterinary Council is due for renewal be renewed before joining as Veterinary Pharmacist.**
4. He/ She should produce copies of educational qualifications/ certificates duly attested and verified by the Head of office.
5. He/ She will be on probation period initially for 2 years which can be extended by one year if needed.
6. He/ She is liable to be posted anywhere in Himachal Pradesh.


