

OFFICE ORDER

WHEREAS, Sh. Bihari Lal Chauhan, Animal Husbandry Assistant, posted at Veterinary Hospital Kalpa, Distt. Kinnaur, Himachal Pradesh, filed a Civil Writ Petition in the Hon'ble High Court of Himachal Pradesh under CWP No. 8605/2024, regarding his transfer from tribal area to soft area, which was decided by the Hon'ble High Court of Himachal Pradesh on 23.08.2024 with the observations as under:-


“The representation which has been filed by the petitioner is decided by the competent authority within a reasonable time.
