
It is further ordered that Sh. Baldev Chand, Veterinary Pharmacist mentioned at Sr. No. 20 will join at new place of posting on or after 01.09.2024 after retirement of present incumbent on 31.08.2024.

This promotion shall be considered from the date of joining at the specified institution. Initially, the service of the employee to the post of Animal Husbandry Assistant will be on probation for 2 years from the date of joining.

Promoted employee would give his pay fixation option along with undertaking certificate within one month from the date of joining. The employee declining promotion for reasons acceptable to the Appointing Authorities will not be promoted for one year or till a vacancy arises, whichever is later. He will also forego his seniority in the first panel.


The salary of employee will be drawn under that designation, under which they have been promoted from the date of taking over the promotion. **All promoted employees are directed to join at new place of posting within 05 days from the date of issue of this order.** If any promoted employee fails to join up to the given time period, then his promotion order will be deemed cancelled/withdrawn and his next eligible junior employee will be promoted in his place. Seniority of the promoted employees will be in the same order to the higher rank, the order in which seniority was in the Veterinary Pharmacist cadre.
