OFFICE ORDER

WHEREAS, Sh. Gur Lal, Animal Husbandry Assistant, posted at Veterinary Hospital Gondhla, District Lahaul & Spiti, Himachal Pradesh, filed a Civil Writ Petition in the Hon'ble High Court of Himachal Pradesh under CWP No. 6907/2024, regarding transfer from tribal area to soft area, which was decided by the Hon'ble High Court of Himachal Pradesh on 18.07.2024 with the observations as under:-

"The petitioner prays that he has made representation to the competent Authority for his transfer to station of his choice, as he has completed more than two years of service at Veterinary Hospital Gondhala District Lahul Spiti, which is a tribal area. This petition is disposed of with the direction that appropriate order on the representation of the petitioner be passed by the competent Authority within a period of four weeks' from today and taking into consideration the fact that the petitioner has already completed more than two years of service at his present place of posting, endeavor be made to place the petitioner at a station of his choice, if possible. However, in case, the station of his choice is not available, then, the petitioner may be transferred to some other place, which is not a tribal area".

WHEREAS, the applicant has made a representation through counsel to the undersigned on dated 08.08.2024 and requested to transfer him to one of the stations mentioned in the above representation.

THEREFORE, keeping in view the judgment/orders passed by the Hon'ble High Court of Himachal Pradesh, his representation has been considered sympathetically by the undersigned and the petitioner is hereby ordered to be transferred and posted at Veterinary Hospital Darang (Palampur), District Kangra vice Sh. Hem Raj, AHA.




