

Director, Animal Husbandry, Himachal Pradesh, Shimla-5 invites applications from Persons with Disability (only Hearing Handicapped/ Partially Deaf) who have passed the prescribed Veterinary Pharmacist Training Course of two years duration and Diploma to this effect should have been issued by the CSKHPKV, Palampur or should have passed two years duration course with equivalent syllabus as prescribed by CSKHPKV, Palampur for Veterinary Pharmacist training from a University/Institution recognized by State/Central Government and also recognized by Himachal Pradesh Para Veterinary Council. The candidates should be registered with Himachal Pradesh Para Veterinary Council, Shimla-5. The posts are for recruitment as Veterinary Pharmacist in the Pay Band ₹ 5910-20200+₹2800 Grade Pay with fixed contractual emoluments of ₹8710/- + 150% of Grade Pay per month (pre-revised) on contractual basis. 

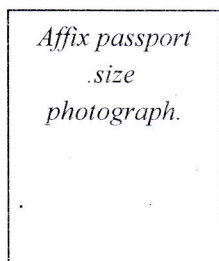
