MEMORANDUM

Whereas Rule 3(5) of Himachal Pradesh State Veterinary Council (General) Rules, 1992 required that every registered practitioner registered under Section 44 of the Indian Veterinary Council Act shall renew his/her registration after every 5 years, by sending an application to the Registrar accompanied by the prescribed fee of Rs.15/- & Rs. 1,000/- (processing & maintenance) totaling to Rs. 1,015/-.

And whereas, the following Veterinary Practitioners have already been informed vide this Council letter No. HVC-1-77/2010-409-605, dated: 23rd February, 2022 and requested to get their registration renewed by 31-03-2022 but they have failed to renew their registration till date.

Therefore, undersigned under provision of Section 48(2) of the Indian Veterinary Council Act, 1984 hereby remove the names of following registered Veterinarians from the Himachal Pradesh State Veterinary Register forthwith.
