TERMS AND CONDITIONS:-

- In case of Ward of Freedom Fighter (Married women), this appointment is subject to the final outcome of LPA No. 215/2015 titled as Jyoti Kumari and others pending before the Hon'ble High Court of H.P and SLP No. 31435/2016-titled as State of H.P and others V/s Neelam Kumari pending before the Hon'ble Supreme Court of India.
- 2. Before accepting the joining of the candidate DD/AD will ensure that category certificate i.e. SC/ST/OBC (parental certificate) issued by the Govt. of Himachal Pradesh is provided by the candidate.
- 3. The service of the contract appointee will be purely on temporary basis. The appointment is liable to be terminated incase the performance/ conduct of the contract appointee is not found satisfactory.
- 4. Contract appointee will be entitled for one day casual leave after putting one month service. However, the contract appointee will also be entitled for 180 days maternity Leave, 10 days medical leave and 5 days special leave. He/ She shall not be entitled for Medical Re-imbursement and LTC etc. No leave of any other kind except above is admissible to the contract appointee.
