
OFFICE ORDER

Consequent upon the approval conveyed by the Himachal Pradesh Government vide their letter No. AHY-B(15)-14/2017 dated 04th February, 2020 & 9th September, 2021 as per the report submitted by the ITI, Nahan Distt. Sirmaur, HP regarding passing the pre-typing test, verification of the credentials by the Screening Committee Sh. Ankit Kumar S/o Late Shri Jasbeer Singh is hereby offered appointment to the post of Clerk (on Contract Basis), in the pay band of ₹ 5910 - 20200 + ₹ 1900 Grade Pay on the following terms and conditions:-

1. The appointment is subject to the final outcome of the cases related to compassionate appointment which are lying pending in the Hon'ble Supreme Court of India.
2. The contract employee will be entitled for fixed annual hike of 3% of the initial PB+GP i.e. ₹234 per year in accordance with Finance Department instruction.
3. The service will be purely on temporary basis and can be terminated by either party by giving one month's notice or one month salary in lieu thereof. The termination will be in case the performance/conduct of the contract appointee is not found good or if the report about Character and antecedents is not found satisfactory. On such termination the Appointee shall not be entitled to any compensation, whatsoever.
4. This appointment will not confer any right of continuation, seniority, confirmation and regularization of service etc.
5. The Appointee should produce a Medical Certificate of fitness from competent authority for which he should get a letter from his Head of Office addressed to Medical Officer concerned for Medical Examination.
6. The Appointee should produce attested copies of educational qualification and as well as age certificates. If at any stage, the diploma /certificate of qualification are found to be obtained from unrecognized institutions, his/her service will be terminated immediately.
7. The Appointee is liable to be posted anywhere in Himachal Pradesh subject to the availability of post.
8. The Appointee shall have to work in any office of the Department for the stipulated period of the contract and shall not be liable to transfer to any other office in the state of Himachal Pradesh, if not required on administrative or any other reasons.
9. The Appointee should furnish a declaration that he/she shall have not more than one living spouse at any time without the permission of the competent authority.
10. The Appointee should undertake oath of allegiance to the Constitution of India.
11. The Contractual Appointee should produce Bonafide certificate of concerned state from the 1st Class Magistrate at the time of his joining.
12. The Appointee should produce SC/ST/OBC/Handicapped/ Ex-serviceman/Wards of Freedom fighter/IRDP/Antodaya Certificate etc at the time of joining.
13. The Contractual Appointee shall be entitled for one day's casual leave after putting one month service. However, the contract appointee will also be entitled for 180 days maternity leave, 10 days medical leave and 5 days special leave. He/she shall not be entitled for medical re-imbursement and LTC etc. Un-availed casual leave, medical leave and special leave can be accumulated upto the calendar year and will not be carried forward for the next calendar year. No leave of any other kind except above is admissible to the contract appointee.

4. Unauthorized absence from the duty without the approval of the controlling Officer shall automatically lead to the termination of the contract. Contract Appointee shall not be entitled for contractual amount for the period of absence from duty.
15. FRSR, pension rules, leave rules, GPF Rules etc. are not applicable to him/her.
16. The Employees Group Insurance Scheme will not be applicable to the Contractual Appointee as well as EPF/GPF.
17. During the period of Contract, in case the Contractual Appointee has to undertake journey due to official work/training, he/she shall be entitled for TA/DA at par with regular counterparts at minimum of pay scale.
18. Before accepting the joining of the candidate, the Head of offices concerned will ensure to obtain the duly filled and signed form the appointee for character and antecedents certificate.
19. In case Character & Antecedents of the candidate is found not satisfactory or any false information is given by the candidate in his/her self declaration, the appointment will be cancelled forthwith and other criminal/legal action will also be taken, as a consequence.
20. No TA/DA shall be paid to the Appointee for joining the contract service.
21. All applications made by the Appointee for any other posts prior to joining this contract service will be treated as cancelled and no request for permission for appearing for interview or for being released if selected will be entertained.
22. Other conditions of contract service as amended from time to time shall be applicable.

The Contractual Appointee has to sign a contract agreement (as per proforma attached) through the Director, Animal Husbandry, Himachal Pradesh, failing which joining will not be accepted. In case the above terms and conditions of Contractual Appointment are acceptable to him, he should report for duties along-with requisite certificates in the Directorate of Animal Husbandry, HP within 15 days from the date of issue of this order, failing which this offer will be treated as cancelled.



FORM OF CONTRACT / AGREEMENT TO BE EXECUTED BETWEEN THE APPOINTEE & GOVT. OF HIMACHAL PRADESH THROUGH DIRECTOR, ANIMAL HUSBANDRY, HIMACHAL PRADESH.

This agreement is made on this _____ day of _____ in the year _____ between _____ contract appointee (hereinafter called the FIRST PARTY). AND the Governor, Himachal Pradesh through Director, Animal Husbandry, Himachal Pradesh (here-in-after the second party).

Whereas, the SECOND PARTY has engaged the aforesaid FIRST PARTY and the FIRST PARTY has agreed to serve as a Clerk on contract basis on the following terms and conditions:-

1. That the FIRST PARTY shall remain in the service of the SECOND PARTY as a Clerk, till further order, commencing on day of _____ and remain in service till further order or his/her replacement by any regular incumbent whichever is earlier. It is specifically mentioned and agreed upon by both the parties that the contract of the FIRST PARTY with SECOND PARTY shall ipso-facto stand terminated by an order of competent authority or his/her replacement by any regular incumbent whichever is earlier.
2. The contract salary of the FIRST PARTY will be Rs.----- in lump sump only per month for a period of one year.
3. The service of FIRST PARTY can be terminated by either party by giving one month notice or one month's salary in lieu thereof.
4. The appointment shall be subject to medical fitness from a competent Medical Authority and also verification of character and antecedents.
5. The contract appointment will not confer any right of continuation seniority and confirmation etc.
6. The FIRST PARTY appointed at a particular Office will have to work there for the stipulated period of the contract and shall not be liable to transfer to other office.
7. If the FIRST PARTY commits any kind of misconduct, in that event, the SECOND PARTY will be competent to terminate this agreement after holding enquiry. On such termination the FIRST PARTY shall not be entitled to any compensation, whatsoever.
8. The contractual appointment will not confer any right for regular appointment.
9. Before joining the service, the FIRST PARTY shall submit following documents:-
 - (a) Certificate of Medical fitness issued by the Competent Medical Authority.
 - (b) A declaration to the effect that the appointment (s) has not, shall not have more than one spouse or shall not marry a person who have a living spouse.
 - (c) An oath of allegiance faithfulness to the Constitution of India for making a solemn affirmation to that effect.
 - (d) The Contractual Appointee (s) shall have to produce the following certificates at the time of his/her joining the duties:-
 - (i) Educational qualification Certificates/ certificate of age i.e. a copy of Matriculation Certificate passed from the recognized Board.
 - (ii) Character Certificate from a Magistrate Ist Class or Gazetted Officer to whom the candidate may be known for the past 3 years.
 - (iii) Bonafide Himachal Certificate from a Magistrate Ist Class.
 - (iv) Certificate of SC/ST/OBC/Handicapped etc from a Magistrate Ist Class.
10. The FIRST PARTY shall be entitled to get one day casual leave for every completed month of service.
11. No. TA/DA will be paid to the FIRST PARTY for joining the contract service.
18. During the period of contract, in case the Clerk. (Contractee) has to undertake journey due to official work/training etc. , he/she shall be entitled for TA/DA at par with regular counterparts at minimum of pay scale.

19. The Employees Group, Insurance Scheme will not be applicable to the contractual appointee(s) as well as EPF/GPF.
