Kindly refer to this Council's letter of even No. dated 27.01.2020 forwarding therewith soft copy of the Draft Electoral Roll in respect of your State/UT Veterinary Council for display in the office of the State/UT Veterinary Council and inspection by the registered practitioners as provided under Rule 5 of the Indian Veterinary Council (IVC) Rules 1985 along with four proformas for change of address and updation of Mobile Number and E-mail ID, lodging of objection to an entry and inclusion of name etc in the Draft Electoral Roll.

In this context, it has been decided to display Draft Electoral Roll during the period from 07th February 2020 to 21st February, 2020 for 15 days as provided under Rule 6 of IVC Rules 1985 for which a Public Notice is being issued for wide circulation. - All claims/objections/change of address/deletion of names, Mobile Numbers, Email ID etc should be invariably submitted in the prescribed proformas as already sent to your State/UT Veterinary Council vide this Council's letter of even No. dated 27.01.2010 duly signed/countersigned by the Registrar, State/UT Veterinary Council.
- Kindly arrange to display the draft Electoral Roll at the office of State/UT Veterinary Council w.e.f 07.02.2020 to 21.02.2020 for inspection by the Registered Veterinary Practitioners.
- The last date for receipt of claims/objections etc from the Registered Veterinary Practitioners by the Registrar of the State/UT Veterinary Council shall be 07.03.2020 (i.e. 15 days).

- 4. All claims or objections received by the Registrar of the State/UT Veterinary Council in the prescribed forms A to D as enclosed (Separate for each practitioner) should be sent as per rule 7(4) of the IVC Rules, 1985 so as to reach the office of the undersigned on or before 16.03.2020 positively. The soft copy and hard copy of claims or objections may be sent simultaneously.
- 5. In case no claim/objection/change of address/deletion of names on account of death/transfer/ Mobile number/ E-mail ID etc in the prescribed format as mentioned above is received by this Office by 16.03.2020, it will be presumed that no claim/objection/change of address/mobile number/e-mail ID etc has been made by the registered practitioners and the Electoral Roll shall be finalized accordingly.
- 6. No further correspondence in this regard shall be entertained under any circumstances.
- 7. The Registrar of the State/UT Veterinary Councils is also requested to kindly go through the draft Electoral Roll and make necessary amendment, if any, as provided under Rule 7 of the IVC Rules, 1985 and intimate the same through remarks in the Draft Electoral Roll for taking further necessary action by the undersigned.
- 8. The Registrar should take necessary steps for making wider publicity of the matter for general awareness amongst the Registered Veterinary Practitioners.
- 9. No cognizance shall be taken by the undersigned, if the information as mentioned above are not received in the prescribed format and signed by the concerned Registrar or for delay submission i.e. after 21<sup>st</sup> February, 2020.
- 10. This may kindly be dealt with due priority to fulfil the statutory requirements as provided under the IVC Act, 1984 and the IVC Rules, 1985.

No.478 of 2018 filed by Dr. Ravinder Chaudhary and subsequent notification issued by the Central government (Department of Animal Husbandry & Dairying, Ministry of Fisheries, Animal Husbandry & Dairying, Government of India) vide Extra-ordinary Gazette of India dated 09.12.2019 calling upon the persons enrolled in the Indian Veterinary Practitioner's Register (IVPR) to elect Members from amongst themselves for the Veterinary Council of India as provided under Section 3(3)(g) of the Indian Veterinary Council (IVC) Act, 1984. The Draft Electoral Roll has been prepared as provided under rule 4 of the Indian Veterinary Council (IVC) Rules, 1985 and other provisions amended in IVC (Amendment) Rules, 2019.

The Electoral Roll contains the names of all the RVP whose names have been included in the IVPR upto 31.03.2019. Further, Mobile Number and Email Id of RVP as provided by the Registrar of State/U.T. Veterinary Councils have also been incorporated in view of IVC (Amendment) Rules, 2019.

The said Roll has been made available at the offices of all the State U.T. Veterinary Councils for display during the period from  $07^{th}$  February to  $21^{st}$  February,2020. The Roll is also available at the office of this Council.

# Copy of the Rule 6 and 7 of the Indian Veterinary Council Rules, 1985.

### Rule - 6:

**Period for lodging claims and objections** – Every claim for inclusion of a name in the roll and every objection to an entry therein shall be lodged within a period of fifteen days from the date of publication of the roll in draft under rule 5.

### Rule -7:

Form of claim and objection and the manner of their disposal -(1) Every Claim shall be signed by the person who requires his name to be included in the roll. (2) Every objection to the inclusion of a name in the roll shall be preferred by a person whose name is already included in the roll and shall be countersigned by another person whose name is also included in such roll. (3) Every claim or objection, as the case may be, shall be presented to the Registrar of the State Veterinary Council in whose register the name of the claimant has been included, or as the case may be, from whose register the objector requires a name to be deleted. (4) The Register shall, before the expiry of fifteen days from the date of receipt of the claim or objection, as the case may be, forward such claim or objection to the Secretary with his remarks thereon, and, where it is considered necessary, with amendments in the State Veterinary Register as provided under sub-section (4) of Section 23.
