Notification

In exercise to powers conferred by section 10 of the Himachal Pradesh Prohibition of Cow Slaughter Act, 1979 (Act 11 of 1979), the Governor, Himachal Pradesh is pleased to make the following rules to amend the Himachal Pradesh Prohibition of Cow Slaughter Rules, 1980 notified vide this Department's notification No. Pashupalan-Ka(3)-1/1979 dated 18.9.1980 and published in the Rajpatra, Himachal Pradesh dated 28.3.1981, namely:-

Short Title            1. These rules may be called the Himachal Pradesh Prohibition of Cow Slaughter (Amendment) Rules, 2010.

Insertion of rule 7-A.    2. In Himachal Pradesh Prohibition of Cow Slaughter, Rules, 1980 (herein-after referred to as the said rules), after rule 7, the following rules shall be inserted, namely:-

“7-A Permit for export of Cows:-

(1) A permit for the export of cows under sub-section (2) of section 4 B of the Act shall be issued in Form EE.

(2) Special permit for export of cows under section 4 C of the Act shall be issued in Form EEE.

(3) The fee for issuing a permit under sub-section(2) of section 4 B and section 4 C of the Act shall be ₹ 50/- per animal in case of cow/heifer/bull/bullock/ox/ male calf, however for issuing special permit in matters of public interest, like transport of

cows to the Gosadans of other States, the competent Authority shall have power to waive off the fee.

Insertion of 3. In the said rules, after Form-'E', the Forms 'EE' following Forms "EE" and "EEE" shall be and "EEE". inserted, namely:-
