The regulations made by the department in 1984 for training course of Vety. pharmapist, have been held in abeyance and new guidelines have been approved by the Government, a copy of which is enclosed for compliance.

1. ENTRANCE TEST FEE/ENTRANCE TEST

A written entrance test will be conducted by the C.S.K.H.P.K.V., Palampur for selection of candidates for admission to the two years training course. The entrance test fee will be Rs.200/-for the candidates belonging to general category and Rs.100/- for the candidates belonging to the reserved categories. The written entrance test will consist of 90 marks and will be of the nature of objective type questions relating to Veterinary Science and general awareness. The names of 3 times the number of trainees will be recommended to the Department for being called for personal interview worth 10 marks before final selection.

2. ELIGIBILITY

The candidate should be a bonafied resident of Himachal Pradesh and should have passed 10+2 examination.

3.AGE

The candidates appearing in the entrance test for two years pharmacists training course should be between the age of 18 to 28 years on the 1st day of January of the year in which the written entrance test will be conducted (Relaxable by 5 years in the case of SC/ST/other categories as may be ordered by the Govt. from time to time).

4. RESERVATION

The admission to the training course for Veterinary pharmacists will be subject to the orders regarding reservation for SC/ST/OBC, IROP or other categories of persons in accordance with the instructions issued by the Government from time to time. However 12.5% candidates of the batch (400 candidates) will be reserved for class-IV candidates of Animal Husbandry Department having 5 years service in the Department after fulfilling the requisite qualification as laid down above.

5. AUTHORITY/AGENCY TO IMPART TRAINING OF VETERINARY PHARMACISTS:

The training to the four hundered candidates will be imparted by the H.P.Live-stock Development Board at five training centres at different places in the Pradesh to the batch consisting of 80 trainees at each training centre.

6.FEE CHARGEABLE FROM THE VETERINARY PHARMACISTS TRAINEES BY THE H.P.LIVE-STOCK DEVELOPMENT BOARD

The trainees selected for Veterinary pharmacists training on the basis of the entrance test will have to deposit fee amouging to Rs.4800/- annually to be paid equally in four quarters of the year with the H.P.State Live-stock Development Board. However, the trainees belonging to reserved categories will have to pay fee of Rs.3600/- annually to be paid in similar manner to the said Board. This fee will be payable to the H.P.Live-Stock Development Board in lieu of the infrastructure and other facilities provided by it to the trainees during the course of the training programme.

7.FINAL EXAMINATION/CERTIFICATE TO THE VETERINARY PHARMACISTS:

Final Examination after completion of the prescribed training course will be conducted by the Department of Animal Husbandry on annual basis and certificates will be awarded to the successful candidates by the Department itself. The amount of fee to be charged from the trainees for final examination will be determined by the Department subsequently.
